Councilwoman DeSouza read AN ORDINANCE AMENDING SECTIONS 151.12 (POLICE CLERKS; APPOINTMENT; DUTIES) AND 151.13 (POLICE CLERKS; OVERTIME) OF CHAPTER 151 OF THE CODIFIED ORDINANCES OF THE CITY OF PARMA HEIGHTS, AND DECLARING AN EMERGENCY. ONE READING ONLY.


