The undersigned deposits with this proposal a certified check drawn on a solvent bank for \$ 200.00 dollars, the same being payable to the City of Parma Heights.

The undersigned agrees that if he is awarded the contract, he will, within five (5) days after receipt of written purchase order, acknowledge said receipt in writing and said acknowledgment shall be deemed a binding contract to furnish to the City of Parma Heights the material as specified for the prices provided for in said proposal.
