

ORDINANCE NO. 2016-19

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE STATE OF OHIO DIRECTOR OF TRANSPORTATION FOR BRIDGE INSPECTION SERVICES, AND DECLARING AN EMERGENCY

WHEREAS, the City of Parma Heights, referred to as the Local Public Agency (LPA) desires to enter into Bridge Inspection Program Services with the Ohio Department of Transportation (State); and,

Whereas, the LPA has determined the need for the described project:

Bridge Inspection Program Services, including, but not limited to bridge load rating calculations, scour assessments, bridge inspections, and fracture critical plan development.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Parma Heights, County of Cuyahoga and State of Ohio:

Section 1. Consent Statement. Being in the public interest, the LPA gives consent to the Director Transportation to complete the Bridge Inspection Program Services, including, but not limited to bridge load rating calculations, scour assessments, bridge inspections, and fracture critical plan development.

Section 2. Cooperation Statement. The LPA shall cooperate with the Director of Transportation in the above described project as follows:

The State shall assume and bear 100% of all of the cost for Bridge Inspection Program Services requested by the City and agreed to by the State. Eligible Bridge Inspection Services are described in the Consultant's Scope of Services Task Order Contract (Exhibit A).

The LPA agrees to pay 100% of the cost of those features which are not included in Exhibit A.

Section 3. Utilities and Right-of-Way Statement. The LPA agrees that all right-of-way required for the described project will be made available in accordance with current State and Federal regulations.

Section 4. Authority to Sign. The Mayor is authorized to enter into contracts with the Director of Transportation which are necessary to complete the above described project.

Section 5. Open Meetings. This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted in those formal actions were in meetings open to the public, in compliance with the law.

Section 6. Emergency Clause. This Ordinance is declared to be an emergency measure necessary for the public peace, health and safety of the Municipality and for the further reason it is necessary to expedite the highway project and to promote highway safety; wherefore, this ordinance shall be in full force and effect immediately upon its passage by Council and approval by the Mayor.
