

ORDINANCE NO. 2019 - 20

AN ORDINANCE PERMITTING THE DIRECTOR OF PUBLIC SERVICE TO PURCHASE PERSONAL PROTECTIVE BUNKER GEAR FROM WARREN FIRE EQUIPMENT INC., VIA A LEASE PURCHASE AGREEMENT WITH MUNICIPAL LEASING CONSULTANTS, AND AUTHORIZING THE MAYOR TO ENTER INTO SAID AGREEMENT AND DECLARING AN EMERGENCY

WHEREAS, the Department of Administrative Services for the State of Ohio has listed Warren Fire Equipment, Inc. as a vendor; and

WHEREAS, the Department of Administrative Services for the State of Ohio has the above-captioned equipment listed in state bid pricing; and

WHEREAS, there is a need to purchase from Warren Fire Equipment, Inc. Personal Protective Bunker Gear, as identified as Exhibit A; and,

WHEREAS, no bidding is required because the aforesaid Personal Protective Bunker Gear is being purchased at the state bid price from the vendor listed on the State Bid or at a price lower than the state bid pricing from an alternate vendor; and,

WHEREAS, the financing of this Personal Protective Bunker Gear described in Exhibit A will be through Municipal Leasing Consultants via a lease with an option to purchase at the termination of said lease; and,

WHEREAS, this Council is obviating the formal competitive bidding process for the purchase of aforesaid Personal Protective Bunker Gear by the authority granted to it in Article V Section 6 of the Charter, and Sections 145.08 and 145.09 of the Codified Ordinances.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Parma Heights, County of Cuyahoga, and State of Ohio:

Section 1. The Director of Public Service is authorized to purchase from Warren Fire Equipment, Inc. Personal Protective Bunker Gear for use by the Fire Department.

Section 2. The financing of the aforesaid Personal Protective Bunker Gear for the Fire Department will be via a lease with an option to buy through Municipal Leasing Consultants.

Section 3. The Mayor is authorized to execute on behalf of the Municipality a lease purchase agreement with Municipal Leasing Consultants as approved by the Director of Law.

Section 4. This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a

majority of the members of the Council that resulted in those formal actions were in meetings open to the public, in compliance with the law.

Section 5. This Ordinance is declared to be an emergency measure necessary for the public peace, health and safety of the Municipality and for the further reason it is necessary to obtain Personal Protective Bunker Gear for the Fire Department; wherefore, this ordinance shall be in full force and effect immediately upon its passage by Council and approval by the Mayor.
