

AN ORDINANCE AUTHORIZING THE MAYOR TO DISPOSE OF OBSOLETE CITY VEHICLES AND EQUIPMENT AT A PUBLIC SALE THROUGH GOVPLANET/IRONPLANET, AND DECLARING AN EMERGENCY

WHEREAS, the Council authorized membership in the National Joint Power Alliance [now known as Sourcewell], a purchasing cooperative in Ordinance No. 2017 – 3; and,

WHEREAS, GovPlanet/IronPlanet is a vendor of the National Joint Power Alliance [now known as Sourcewell]; and,

WHEREAS, GovePlanet/Iron Planet will provide the City of Parma Heights with auction services for the disposal of obsolete city vehicles, and;

WHEREAS, the Director of Public Service recommends that the vehicles listed on Exhibit A be removed from service as a result of their age and mechanical condition; and,

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Parma Heights County of Cuyahoga and State of Ohio;

Section 1. The Mayor is authorized and directed to dispose of obsolete city vehicles at a public sale through GovPlanet/IronPlanet, a list of which is attached hereto and incorporated herein as Exhibit "A" at a public sale,

Section 2. Council finds and determines that all formal action of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted ill those formal actions were in meetings open to the public, in compliance with the law.

Section 3. This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of said City and for the further reason it is necessary to authorize the disposal of obsolete City vehicles; wherefore, this ordinance shall be in full force and effect from and immediately after its passage by Council and approval by the Mayor.
