

RESOLUTION NO. 2018-3

A RESOLUTION GRANTING A PERMANENT STORMWATER EASEMENT FOR THE PURPOSE OF INSTALLING AND CONSTRUCTING, RECONSTRUCTING, IMPROVING, OPERATING, REPAIRING, INSPECTING, RENEWING, MAINTAINING, REMOVING AND REPLACING STREAM BANK EROSION CONTROL FACILITIES ON PERMANENT PARCEL NUMBER 473-21-039 (BIG CREEK) AND DECLARING AN EMERGENCY.

WHEREAS, the Northeast Ohio Regional Sewer District has determined it is necessary to stabilize the banks of the Big Creek as it passes north under Pearl Road near York Road. The stream bank protection will be partially on permanent Parcel Number 473-21-039, Big Creek Parcel; and,

WHEREAS, a permanent easement is needed to perform the work associated with the construction, reconstruction, improvements, operation, repair, inspection, renewal of, maintaining, removing and replacing of stream bank erosion control facilities.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Parma Heights, County of Cuyahoga and State of Ohio:


Section 1. This Council does grant the easement to perform the work associated with the construction, reconstruction, improvements, operation, repair, inspection, renewal of, maintaining, removing and replacing of stream bank erosion control facilities and supports for certain real premises located within the Colombo Park property in the City, in the form of Exhibit A attached hereto and made a part hereof as though fully rewritten herein.

Section 2. This easement is necessary for the Northeast Ohio Regional Sewer District to construct stream bank erosion protection facilities at Colombo Park. This Council recognizes that all costs associated with the installation and ongoing maintenance and repair of the stream banks will be the responsibility of the City of Parma Heights and the Northeast Ohio Regional Sewer District.

Section 3. This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted in those formal actions were in meetings open to the public, in compliance with the law.

Section 4. This Council declares this Resolution to be an emergency measure for the immediate preservation of the public health, peace and safety of this municipality and for the further reason that it is immediately necessary to enter into an easement for the improvements of stream bank erosion protection facilities located in the municipality; wherefore, it shall be in full force and effect immediately after its passage by Council and approval by the Mayor.
