AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH EUTHENICS INC. TO PREPARE CONTRACT PLANS, SPECIFICATIONS AND RIGHT OF WAY PLANS [IF REQUIRED] FOR THE REPAIR AND/OR REPLACEMENT OF THE INDEPENDENCE ROAD BRIDGE OVER BRANDYWINE CREEK AND DECLARING AN EMERGENCY

WHEREAS, the City of Parma Heights has been advised the City Engineer that the Independence Road Bridge over Brandywine Creek is in need of repair and/or replacement; and

WHEREAS, City of Parma Heights is desirous of repairing and/or replacing the Independence Road Bridge over Brandywine Creek: and

WHERAS, the City has applied for funding from the Ohio Department of Transportation Municipal Bridge Grants Program to cover 95% of for the cost of construction to repair and/or replace the bridge deck and abutments; and

WHERAS, the City Engineer is meeting with ODOT on September 16, 2019 to present a grant application for the bridge repair and/or replacement project; and

WHEREAS, in the event the City is successful in obtaining grant funding for the cost of the bridge repair and/or replacement project it will be necessary to engage the services of consultants; and

WHEREAS, the Director of Public Service and the City Engineer have determined that Euthenics, Inc. and its subcontractors are qualified to prepare contract plans, specifications and right of way plans, [if required] for the repair and/or replacement of the Independence Road Bridge over Brandywine Creek.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Parma Heights, County of Cuyahoga and State of Ohio:

- <u>Section 1</u>. The Mayor of the Municipality of Parma Heights, Ohio, is authorized and directed to execute on behalf of the municipality an Agreement with Euthenics Inc. substantially in the form set forth as Exhibit "A", attached hereto and made a part hereof by reference, as if fully rewritten.
- <u>Section 2.</u> The authority granted in Section 1 is contingent upon the City obtaining funding in the amount estimated to be \$1,028,090.00for the repair and/or replacement of the Independence Road Bridge over Brandywine Creek.
- <u>Section 3.</u> The Agreement shall be upon terms and conditions as approved by the Director of Law prior to the execution of the agreement(s) by the Mayor on behalf of the City.
- <u>Section 4</u>. This Council finds and determines that all formal action of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted in those formal actions were in meetings open to the public,

in compliance with the law.

<u>Section 5.</u> This Council declares this Ordinance to be an emergency measure for the immediate preservation of the public health, peace and safety of this municipality and for the further reason that it is necessary to repair and/or replace the Independence Road Bridge over Brandywine Creek; wherefore, it shall be in full force and effect immediately after its passage by Council and approval by the Mayor.
