ORDINANCE NO. 2022 - 16

AN ORDINANCE PERMITTING THE DIRECTOR OF PUBLIC SERVICE TO PURCHASE ONE (1) 2022 RAM 2500 TRADESMAN VIA PURCHASE ORDER WITH BRUNSWICK AUTO MART AND AUTHORIZING THE MAYOR TO ENTER INTO SAID AGREEMENT, AND DECLARING AN EMERGENCY

WHEREAS, the Director of Public Service has determined the need for and recommends that this Council authorize the purchase of a new service truck for the efficient operation of the Department of Public Service; and

WHEREAS, Brunswick Auto Mart has a 2022 Ram 2500 Tradesman ("Truck") for a price of Forty-Nine Thousand Nine Hundred and Ninety-Five Dollars (\$49,995.00) as identified as Exhibit A attached hereto; and

WHEREAS, no bidding is required because the Truck is being purchased below the threshold for competitive bidding.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Parma Heights, County of Cuyahoga, and State of Ohio:

<u>Section 1</u>: That the Director of Public Service is authorized to purchase from Brunswick Auto Mart one (1) 2022 Ram 2500 Tradesman for the sum of Forty-Nine Thousand Nine Hundred and Ninety-Five Dollars (\$49,995.00) as described in Exhibit A.

Section 2: This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted in those formal actions were in meeting open to the public, in compliance with the law.

Section 3: This Ordinance is declared to be an emergency measure necessary for the public peace, health and safety of the Municipality and for the further reason it is immediately necessary to authorize a purchase order to retain this price; wherefore, this ordinance shall be in full force and effect immediately upon its passage by Council and approval by the Mayor.
