ORDINANCE NO. 2022 - 17

AN ORDINANCE AUTHORIZING THE ADMINISTRATION TO ENTER INTO A LEASE WITH INTENT TO PURCHASE AGREEMENT FOR ONE (1) BOBCAT SKID-STEER LOADER FROM CLARK EQUIPMENT COMPANY DBA BOBCAT COMPANY AT A STATE PURCHASE PRICE OF \$62,012.24, AND DECLARING AN EMERGENCY

WHEREAS, the Director of Public Service has determined the need for and recommends that this Council authorize the lease with intent to purchase for one (1) Bobcat Skid-Steer Loader from Clark Equipment Company dba Bobcat Company; and,

WHEREAS, Clark Equipment Company dba Bobcat Company has a S770 T4 Bobcat Skid-Steer Loader to lease to the City of Parma Heights with the intent to purchase for the sum of Sixty-Two Thousand, Twelve Dollars and Twenty-Four Cents (\$62,012.24), as indicated by attached Exhibit A, incorporated herein as if fully rewritten; and,

WHEREAS, Council may authorize this acquisition pursuant to the State Purchasing Program without competitive bidding process based upon the authority granted to it in Article V Section 6 of the Charter, and Section 145.08 of the Codified Ordinances.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Parma Heights, County of Cuyahoga and State of Ohio:

Section 1: That the Administration is hereby authorized and directed to enter a lease with intent to purchase agreement with Clark Equipment Company dba Bobcat Company for one (1) S770 T4 Bobcat Skid-Steer Loader for the sum of \$62,012.24, as described in Exhibit A, attached hereto and incorporated by reference.

Section 2: Council does hereby authorize the lease with intent to purchase under the terms described in attached Exhibit A, pursuant to the State Purchasing Program without competitive bidding process pursuant to Article V Section 6 of the Charter, and Section 145.08 of the Codified Ordinances.

Section 3: This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted in those formal actions were in meeting open to the public, in compliance with the law.

Section 4: This Ordinance is declared to be an emergency measure necessary for the public peace, health and safety of the Municipality and for the further reason it is immediately necessary to authorize this acquisition due to scarcity of supply and to prevent disruption of vital city services; wherefore, this ordinance shall be in full force and effect immediately upon its passage by Council and approval by the mayor.
