### Mike Byrne, Mayor

## Mike Pokorny, Director of Law

• Director Pokorny gave an update on the 2020 census. Per our Charter, Article III, Section 1A regarding Wards. The Charter provision requires that at the beginning of 2021 and every ten (10) years thereafter, within 60 days of a proclamation from the Secretary of State announcing the populations of the cities, that the Council shall review the census and divide the City into wards, which shall be as nearly equal in population as is possible, each composed of contiguous and compact territory boundary by natural boundaries or street lines. In 2010, the City engaged the services of Triad Research and Mr. Ted Dykes. On January 27<sup>th</sup>, I wrote a letter to Mr. Dykes informing him that this process was about to begin again and

asked him to contact me to discuss a possible engagement to review the wards in regards to the 2020 Census and re-draw ward boundaries if necessary. As of today, I have not heard back from Mr. Dykes, however, we did receive additional information via some news articles which basically say that some other cities, primarily Cleveland, that requires a re-apportionment no later than April 1<sup>st</sup> based on the census. At this point, the census has not been certified by the Secretary of State and until that is completed we won't be able to go through the process of re-districting if we have to re-draw. I am waiting to hear from Mr. Dykes to contact me because he is the expert and he will know the current status. When I receive further information, I will report back to Council.
