## REPORTS FROM MAYOR AND DIRECTORS

Recreation Director Allen: We are currently still looking for summer staff not only for the pool but also for the community rooms. We have now scheduled Lifeguard training and are making that available not only for our staff but also if anyone is looking to work as a Lifeguard this summer. We have two sessions scheduled, one at the end of May and one at the beginning of June. Our first annual Earth Day in the Commons was held this past Saturday, which was funded partly by NOPEC Community Grants. Madi Bacci was the main coordinator for the event, we had 16 community groups participate in the event including five (5) City Councilmembers and a food truck. We estimate that there were a little over 500 people from the community who attended the event.

Councilwoman DeSouza stated that she has received a lot of compliments on the food truck, good job to you and Madi too, well done. Councilwoman Maruschak seconded that comment and wanted to thank everyone else behind the scenes as well, service, safety please extend our thanks to them, thank you. Councilman Rounds also commented on a what a great day it was, it was a great way to interact with the community and council shared a frisbee, it was fun to see them being used on the commons. It was a great event, thank you again.

<u>Safety Director Heffernan:</u> We are working with the National Testing Network and hopefully both police and fire will pass it within the next 45 days. As of today 27, citizens have taken advantage of the Fire/Red Cross Smoke Detector program, Chief and I are pretty excited about that. The police and fire have been

working together with the pool manager on an incident action plan and emergency response plan. Thank you.

<u>Service Director Sepik</u>: The Parma Heights waste collection services events are located on our website as well as posted on Facebook. Republic Services next bulk pickup will be on May 18th, campaign signs collection will be at the service garage, on May 14<sup>th</sup> from (9:00 to noon), Community Shred Day will be on May 28<sup>th</sup>, Cuyahoga County Soil and Waste Conservation District 23 will be hosting our Annual Big Creek Watershed Cleanup from (9:00 a.m. to noon) on April 30<sup>th</sup>. Volunteers are still needed; they will meet at the Snow Road picnic area.

Councilwoman Maruschak stated she will be volunteering with her family to the Annual Big Creek Watershed Cleanup event. Councilwoman DeSouza stated that working the Big Creek Watershed Cleanup in the past brings back some interesting times.

Councilman Rounds asked about the repairs being made to the potholes, how is this laid out through the community and wards, could you explain the process.

Director Sepik responded that Parma Heights is concentrating on the mains and semi-mains first, before we go into areas. We will begin with the Maplewood area which includes Maplewood all the way through Meadowbrook to Blossom, then we will go to the Mandalay area, then the Snow Road area, then Valley Forge and end up at Kingsdale and then the hot-patch will be concluded, we are also going after funding to do more repair and reconstruction to our streets as well.

<u>Finance Director Iaconis:</u> We are still in the midst of contract negotiations with the Police Sargent's and Captains, we are going to begin with the Fire Departments negotiations tomorrow. The patrolman recently voted almost unanimously to move from the OPBA to the FOP, so we are waiting to hear when we can begin those negotiations. Our ARPA report has been completed and we should be getting our second distribution shortly.

Mayor Gallo: I noted earlier the grants that we have received with grant funding for the North Church Drive construction phases I and II; a CDSG grant to help complete the wayfinding and signage in the Master Plan in the Greenbriar Commons area; Cuyahoga County Solid Use District grant for recycle information that went to the residents; a \$50,000 from the Cuyahoga County Urban Tree Canopy program to enhance the urban canopy areas in our city. The Senior Center's staff served 1,197 meals in the past two weeks. During the last council meeting I mentioned that the late Catherine Bon family asked for contributions to Meals on Wheels in lieu of flowers, and they are please to announce that those donations totaled \$1,080.00 in her memory. It really meant a lot to the family because Meals on Wheels allowed her to stay in her home an additional 3 years. Next month the Senior Center will be able to offer flower arranging, pizza and a movie, painting party, an ice cream social, and a second day free to all of the regular exercises and activities that are being offered at the Senior Center. At the end of May they will be having a birthday celebration for two seniors, one will be 100 years old, the other will be 101 years old. We received official and final approval from the Federal Government to move forward with the construction of the Nathan Hail Basin. Our next step will be going out to bid and hopefully breaking ground in about 6 months with that construction project. The city newsletter should be arriving to households next week or the week after. In that newsletter there is a deer culling survey, we want to hear from the resident what impact the deer have on the community, it will be up until June 11th on the website. There is plenty of time to take the survey, we are looking for your input. Our 155th Memorial Day Ceramony is next month, I mentioned at the last meeting that we will be providing transportation for Veterans and seniors, to and from the Cemetery and the Church and it is the longest running ceremony in the State of Ohio, and we are looking forward to it. I want to thank city councilmembers, the Recreation Department, Service Department, police and fire departments for their work on the Earth Day event. Many more events are coming from the Recreation Department and we will be sure to let council know those dates so they can be in attendance if they so choose. Thank you.

Councilwoman Maruschak asked if the birthday party at the Senior Center will be on the calendar or do you have a date for that event?

Mayor Gallo responded that the date has not yet been set, but as I find out additional information, I will be sure to share it with all of council.

#### PUBLIC SESSION

Council President Rounds: Please stand, state your name and address and please direct all comments to me and you have 3 minutes to speak.

Ms. Sebastian: Tammy Sebastian, 6814 Revere Road. I'd like to speak on the parking permits legislation that was discussed during the Mayor's Caucus, is that okay? I'd like to know if that would include the parking lots for apartments? The vacancies in the commercial buildings, I appreciate the additional emphasis on this matter. I am in favor of condemning the passage of the CCW laws, however I feel a resolution is not enough, actions always have to follow. I wonder if there was a mayor's alliance or council that would have shown support to oppose this before it was passed? There were many unions that did condemn that passage as well.

Council President mentioned that we do not have the language of an ordinance in place regarding the parking matter. I think the intent is just on residential street parking, and that would be a completely different process for apartment complexes.

Ms. Reahm: Phyllis Reahm 6240 Stratford: Can we have the walkway from Stratford back to the Constellation School cleaned and sprayed for poison ivy? Are they going to continue painting the fire hydrants? And we they still check the fire hydrants to be sure they are in working order? The Petro USA property has a curb that distinguishes a sidewalk from their drive, when Valero resurfaced the lot he took the curb out, he has utility and delivery trucks parking on the sidewalk and if you are walking, you can't continue until you get closer to Ackley or Pearl Road. I think he should come up with a plan to keep the vehicles off the sidewalks maybe those round things for plants or posts in with chains to keep people out of the parking area. At the Constellation school on Pearl Road, they don't have school crossing guards because all of the kids are either bussed or their parents come, but the stop here to activate signal isn't used properly, maybe if we could make it a turn on red it could help defer traffic in that area. The driveway coming out to Ackley from the service drive that both the Constellation School and the Ukrainian Academy are sharing. You cannot walk there safely; they do not stop at that stop sign. It's dangerous.

Mr. Pekarek: Roger Pekarek, 11661 Appleton. Status update on planning or where it stands on the Maplewood Gardens, Cornerstone?

Mayor Gallo: The Building Department is working on that with the builders on that project, hopefully they will break ground early summer, our (CBO) Chief Building Official is tightening up some loose ends. I'd also like to address the concern earlier from Ms. Sebastian regarding the Mayors organizations, we do have Mayor's organizations that go to Columbus and lobby on a regular basis on behalf of the cities. I do believe one of the larger groups were there representing us before this House Bill was passed.

## A RESOLUTION AUTHORIZING THE ADMINISTRATION TO PURCHASE TWENTY (20) PORTABLE RADIOS FROM CLEVELAND COMMUNICATIONS AT A STATE PURCHASE PRICE OF \$98,482.80, AND DECLARING AN EMERGENCY

WHEREAS, the Chief of Police has determined the need for and recommends that this Council authorize the purchase of twenty (20) portable radios from Cleveland Communications; and

- WHEREAS, Cleveland Communications has twenty (20) portable radios to sell to the City of Parma Heights for the sum of Ninety-Eight Thousand Four Hundred and Eighty-Two Dollars and Eighty Cents (\$98,482.80), as indicated by the attached Exhibit A, incorporated herein as if fully rewritten; and
- WHEREAS, Council may authorize this acquisition pursuant to the State Purchasing Program without competitive bidding process based upon the authority granted to it in Article V Section 6 of the Charter, and Section 145.08 of the Codified Ordinances.
- **NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Parma Heights, County of Cuyahoga and State of Ohio:
- Section 1: That the Administration is hereby authorized and directed to purchase twenty (20) portable radios from Cleveland Communications for the sum of \$98,482.80, as described in Exhibit A, attached hereto and incorporated by reference.
- Section 2: Council does hereby authorize the purchase under the terms described in attached Exhibit A, pursuant to the State Purchasing Program without competitive bidding process pursuant to Article V Section 6 of the Charter, and Section 145.08 of the Codified Ordinances.
- Section 3: This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted in those formal actions were in meeting open to the public, in compliance with the law.
- Section 4: This Resolution is declared to be an emergency measure necessary for the public peace, health, and safety of the Municipality, and for the further reason it is immediately necessary to authorize this acquisition due to a six-to-eight-week production timeline and to prevent disruption of vital city services; wherefore, this Resolution shall be in full force and effect immediately upon its passage by Council and approval by the Mayor.

A RESOLUTION AUTHORIZING D.J. NEFF ENTERPRISES, INC., DBA NEFF & ASSOCIATES, NUNC PRO TUNC, TO PREPARE THE PLANS, SPECIFICATIONS, AND ESTIMATE OF COST, AND AUTHORIZING EUTHENICS, INC., MUNICIPAL ENGINEER, TO PROVIDE ENGINEERING SERVICES FOR THE NATHAN HALE STORMWATER BASIN PROJECT, AND DECLARING AN EMERGENCY.

WHEREAS, this Council has authorized the Mayor to enter into a Member Community Infrastructure Program (MCIP) Agreement with the Northeast Ohio Regional Sewer District for the Nathan Hale Stormwater Basin Project (Ord. No. 2019-6); and

WHEREAS, to proceed on the Project, Council hereby authorizes D.J. Neff Enterprises, Inc., DBA Neff & Associates, nunc pro tunc, to provide the necessary engineering services indicated in said MCIP Agreement, including but not limited to, preparation of plans, specifications, and cost estimates for such Project improvements, and to file such specification for bidding documents within the Department of Public Service; and

WHEREAS, this Council hereby authorizes Euthenics Inc., Municipal Engineer, to continue with the Nathan Hale Stormwater Basin Project by providing the necessary engineering services indicated in the above referenced MCIP Agreement once the bid process is complete.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Parma Heights, County of Cuyahoga and State of Ohio:

<u>Section 1</u>: This Council authorizes and directs D.J. Neff Enterprises, Inc., DBA Neff & Associates, nunc pro tunc, to prepare plans, specifications, and cost estimates, and Euthenics Inc., Municipal Engineer, to provide the necessary engineering services for the Nathan Hale Stormwater Basin Project.

Section 2: This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted in those formal actions were in meetings open to the public, in compliance with the law.

Section 3: This Council declares this Resolution to be an emergency measure for the immediate preservation of the public health, peace, and safety of this Municipality, and for the further reason that said Resolution is necessary so that such plans, specifications, and estimate of cost may be prepared and filed with this Council to commence the necessary proceedings to eliminate potential and existing hazards to the health and welfare of the City's residents; wherefore, it shall be in full force and effect immediately after its passage by Council and approval of the Mayor.
