RESOLUTION 2022 - 36

A RESOLUTION AUTHORIZING THE ADMINISTRATION TO DISPOSE OF OBSOLETE CITY VEHICLES AND EQUIPMENT AT A PUBLIC SALE THROUGH GOVPLANET/IRONPLANET

WHEREAS, the Council authorized membership in the National Joint Power Alliance [now known as Sourcewell], a purchasing cooperative in Ordinance No. 2017-3; and

WHEREAS, GovPlanet/IronPlanet is a vendor of the National Joint Power Alliance [now known as Sourcewell]; and

WHEREAS, GovPlanet/IronPlanet will provide the City of Parma Heights with auction services for the disposal of obsolete city vehicles and equipment; and

WHEREAS, the Director of Public Service recommends that the vehicles and equipment listed on Exhibit A be removed from service as a result of their age and mechanical condition.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Parma Heights, County of Cuyahoga, and State of Ohio:

- Section 1: The Administration is authorized and directed to dispose of obsolete city vehicles at a public sale through GovPlanet/IronPlanet, a list of which is attached hereto and incorporated herein as Exhibit A at a public sale.
- Section 2: This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted in those formal actions were in meeting open to the public, in compliance with the law.

Section 3. That this Resolution shall take effect and be in force from and after the earliest date provided for by law.

RESOLUTION NO. 2022 - 38

A RESOLUTION AUTHORIZING THE EXECUTION OF AN EXTENSION AGREEMENT BETWEEN THE CITY OF PARMA HEIGHTS AND THE FRATERNAL ORDER OF POLICE/OHIO LABOR COUNCIL, INC. WAIVING THE STATUTORY TIME PERIODS REQUIRED BY OHIO R.C. 4117.14 (G)(11), AND DECLARING AN EMERGENCY

WHEREAS, representatives of the City of Parma Heights and the Fraternal Order of Police/Ohio Labor Council, Inc. have commenced negotiations for a new collective bargaining agreement; and

WHEREAS, it is in the best interest of the City of Parma Heights to authorize the execution of an extension agreement and to waive the statutory time period required by Section 4117.14 (G)(11) of the Ohio Revised Code and to allow the City and the authorized union representative to negotiate the terms of a new agreement, without the aid of a conciliator; and

WHEREAS, it is in the best interest of the City of Parma Heights to allow negotiations to continue past January 1, 2023.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Parma Heights, County of Cuyahoga and State of Ohio:

Section 1. That the Administration and/or its representative is hereby authorized to enter into an extension agreement with the above-referenced union representative, which is attached hereto as "Exhibit A" and made a part hereof by reference, as if fully rewritten, for the purpose of waiving the statutory time periods required by Ohio R.C. 4117.14 (G)(11) which will allow the City of Parma Heights and the appropriate union representative to negotiate without the aid of a conciliator. The Administration and/or its representative is also authorized to enter into an extension agreement so that the negotiations can continue past December 31, 2022, and that the terms of the negotiated contract may be retroactive to January 1, 2023.

Section 2. This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted in those formal actions were in meetings open to the public, in compliance with the law.

Section 3. This Resolution is declared to be an emergency measure immediately necessary for the public peace, health, and safety of the Municipality, and for the further reason that it is immediately necessary to provide continued services of the City employees affected by this agreement without any disruption of service; wherefore, this Resolution shall be in full force and effect from and immediately after its passage by Council and approval by the Mayor.

ORDINANCE NO. 2022 – 34

AN ORDINANCE TO ESTABLISH APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF PARMA HEIGHTS, OHIO DURING THE PERIOD OF JANUARY 1, 2023 TO AND INCLUDING DECEMBER 31, 2023

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Parma Heights, County of Cuyahoga and State of Ohio:

Section 1. That to provide for the current expenses and other expenditures of the City of Parma Heights, Ohio, during the period of January 1, 2023 to and including December 31, 2023, the following sums set forth in Exhibit A, attached hereto and made a part hereof by reference as if fully rewritten, are set aside and appropriated from the General Fund.

Section 2. That the Director of Finance is hereby authorized to draw her warrants from any of the foregoing appropriations upon receiving the proper requisition, certificate, and voucher therefore; approved by the officers authorized by law to approve same, or an Ordinance or Resolution to make the expenditure, provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law and Ordinance.

Section 3. This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted in those formal actions were in meetings open to the public, in compliance with the law.

Section 4. That this Ordinance shall take effect and be in force from and after the earliest date provided for by law.

ORDINANCE NO. 2022 –35

AN ORDINANCE AUTHORIZING AND DIRECTING AN EXPENDITURE FOR PETROLEUM FUELS AND LUBRICANTS, AUTHORIZING AND DIRECTING THE DIRECTOR OF PUBLIC SERVICE TO ADVERTISE FOR COMPETITIVE BIDS THEREFORE, AND AUTHORIZING AND DIRECTING THE ADMINISTRATION TO ENTER INTO A WRITTEN CONTRACT WITH THE LOWEST AND BEST BIDDER, AND DECLARING AN EMERGENCY

WHEREAS, the Council of the Municipality of Parma Heights has been advised that it is necessary that an expenditure for items, as noted in the title, be authorized and directed in accordance with the provisions of Article V Section 6 of the Charter of the City of Parma Heights.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Parma Heights, County of Cuyahoga and State of Ohio:

<u>Section 1.</u> The expenditure of monies of this Municipality for petroleum fuels and lubricants, which expenditure is now estimated to exceed \$50,000.00, is authorized and directed. Said expenditure shall be made from monies appropriated for such purpose.

Section 2. The Director of Public Service is authorized and directed to advertise for competitive bids for such expenditure at least once in a newspaper of general circulation within the Municipality and to post such Invitation to Bid on the City of Parma Heights official web page.

Section 3. The Administration is authorized and directed to enter into a written contract with the lowest and best bidder after such advertising, said lowest and best bidder to be determined by motion of this Council.

Section 4. This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted in those formal actions were in meetings open to the public, in compliance with the law.

Section 5. This Council declares this ordinance to be an emergency measure for the immediate preservation of the public health, peace and safety of the Municipality, and for the further reason that it is necessary to authorize and direct such expenditure so as not to have a disruption of service to the City; wherefore, it shall be in full force and effect immediately after its passage by Council and approval of the Mayor.
