

City of Parma Heights Council Meeting

Monday, February 28, 2022 7:00 PM

Council President: The City Council meeting is called to order on Monday 02/28/2022 at 7:00 p.m.

Roll Call: Haase, Maruschak, Rounds, Stavole, Durichko, DeSouza. Councilwoman Walsh is absent.

Pledge of Allegiance is spoken.

Council President: Asks for motion to excuse Councilwoman Walsh.

Moved by Councilman Stavole. Seconded by Councilwoman Maruschek.

Roll Call: Haase, Maruschak, Rounds, Stavole, Durichko, DeSouza.

Council President: Asks for the clerk to make a correction to a typo in Legislation 2022-1. It should say "consider a resolution authorizing the submission of a grant." No objection.

Motion to approve the minutes from the January 22nd Special Council Meeting, the January 24th Council Meeting, the January 26th Special Council Meeting, and the January 31st Special Council Meeting.

Moved by Councilman DeSouza. Seconded by Councilman Stavole.

Roll Call: Haase, Maruschak, Rounds, Stavole, Durichko, DeSouza.

Motion passes

Mayor: Announces that Dennis Patton has retired from the City of Parma Heights as Service Director. Robert Sepik was sworn in this evening in her office as the City's next Service Director.

Director Sepik: Director Sepik stated they recently hired three new employees for the service department.

Director Allen: The recreation department and the senior center are going to look for opportunities to work together and support each other. They have had 9 different local businesses, including the Mayor, to sponsor baseball teams this spring so far. Children's event is being planned for St. Patrick's Day. Event will be held March 12 and registration for it has begun. Plans are underway for the 155th Annual Memorial Day Ceremony.

Director Heffernan: The Fire Department was involved in a mutual aid for major working fires. Stated that Sgt. Scott Jackson from our Dept. was recognized with a letter from the Brecksville City Police Chief about helping with a sovereign citizen.

Director laconis: She thanks everyone for the consideration of the budget tonight. It will be on for second reading at the first meeting in March.

Director Schneider: He does join the individuals in congratulating Mr. Sepik.

Mayor: The senior center has started to offer special trips again outside of regular transportation. This month, they are going to two fish fries. The senior center has signed up several seniors for Code Red Ready Notify. On March 7th, the senior center is open for anyone interested to get the booster and 1st shots. There is no time yet, but as soon as they receive a time, they will let us know. We received notification that there were several gas stations that were robbed throughout Parma. Two Parma Heights patrolmen had assisted Parma in these robberies.

Director Schneider: There is an amendment to that ordinance. He requests a motion to amend accordingly before moving on with that reading.

Council President: Requests a motion to amend ordinance 2022-2.

This is one reading only.
