**AN ORDINANCE AUTHORIZING THE ADMINISTRATION TO ENTER INTO A PURCHASE AGREEMENT FOR ONE (1) FIRE APPARATUS WITH A VENDOR QUALIFIED BY THE OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES AND AT A STATE PURCHASE PRICE NOT TO EXCEED \$2,000,000.00, AND DECLARING AN EMERGENCY**
