

ORDINANCE NO. 2017-9

AN ORDINANCE PERMITTING THE DIRECTOR OF PUBLIC SERVICE TO PURCHASE ONE VT651 PURE VACUUM SWEEPER VIA A LEASE PURCHASE AGREEMENT WITH HUNTINGTON PUBLIC CAPITAL CORPORATION AND AUTHORIZING THE MAYOR TO ENTER INTO SAID AGREEMENT AND DECLARING AN EMERGENCY

WHEREAS, the Council authorized the Mayor to enter into a Community Cost-Share Agreement with the Northeast Ohio Regional Sewer District, as evidenced by Ordinance No. 2017-4, passed March 27, 2017; and,

WHEREAS, the Community Cost-Share Agreement provides for funding to assist the City with the purchase of a Street Sweeper; and,

WHEREAS, the Department of Administrative Services for the State of Ohio has Johnston North America listed as a vendor; and

WHEREAS, the Department of Administrative Services for the State of Ohio has the VT651 Pure Vacuum Sweeper ("Street Sweeper") listed in state bid price for a price of \$286,792.00 as identified as Exhibit A attached hereto; and,

WHEREAS, no bidding is required because the Street Sweeper is being purchased at the state bid price from the vendor listed on the State Bid ; and,

WHEREAS, the financing of this vehicle will be through Huntington Public Capital Corporation via a lease with an option to purchase at the termination of the lease; and,

WHEREAS, the funding for the lease will be reimbursed to the City as demonstrated in Article 2.0 of the Community Cost-Share Agreement attached as Exhibit B; and

WHEREAS, this Council is obviating the formal competitive bidding process for the purchase of aforesaid police sedans and equipment package by the Authority granted to it in Article V Section 6 of the Charter, and Sections 145.08 and 145.09 of the Codified Ordinances.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Parma Heights, County of Cuyahoga, and State of Ohio:

Section 1. The Director of Public Service has been authorized to purchase a VT651 Pure Vacuum Sweeper from Johnston North America for a total cost of \$286,792.00.


Section 3. The financing of the Street Sweeper shall be via a lease with an option to buy through Huntington Public Capital Corporation for an amount funded by the lease of \$286,792.00.

Section 4. The lease shall be on terms and conditions as approved by the Director of Law.


Section 5. The Mayor is authorized to execute on behalf of the Municipality a lease purchase agreement with Huntington Public Capital Corporation. as approved by the Director of Law.

Section 6. This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted in those formal actions were in meetings open to the public, in compliance with the law.

Section 7. This Ordinance is declared to be an emergency measure necessary for the public peace, health and safety of the Municipality and for the further reason it is necessary to obtain a Street Sweeper for the Service Department; wherefore, this ordinance shall be in full force and effect immediately upon its passage by Council and approval by the Mayor.
