Councilman Haase asked if that day delay affect the New Year collection?

Service Director Sepik responded that he would get back to Councilman Haase.

Councilwoman DeSouza stated while the leaf collection was going to be completed on December 1st, thank you for extending it. The truck that I saw in Ward 4 went through twice in one day. Thank you.

Council President Rounds. Any other questions or comments for Director Sepik? Seeing none. Nice to see you again, Director Schneider. Mayor Gallo....

Mayor Gallo: Thank you, Mr. President. The Monarch Pledge was accepted last week. So once again we are doing the Mayor's Monarch Pledge. There are only 5 mayors in Ohio. We are going to be hosting two basketball clinics in partnership with Holy Name High School. Focusing on passing, shooting and dribbling. Starting in the new year Parma Heights Recreation will be shifting their registration software to My Rec.to streamline things. The Senior Center served and delivered 1,209 meals over the past two weeks. Director James received a donation in the amount of \$200 they will use those funds towards the holiday lunch in December. Seniors went out to breakfast this past Saturday and then when to Pettiti Gardens for photo with Santa. Each participant received a free 4 x 6 photo. The trip to Normandy High Schools Cosmetology Class for manicures and facials was a huge success. We are working on getting the Recreational Trail Grant reimbursement for Nathan Hale Park. Also working on getting our Capital Budget requests in to the state this week. Director Iaconis and I attended a meeting with the Cuyahoga County Library this morning. We are potentially looking at breaking ground by next summer, 2024. Internal discussions took place today. We are very excited.

Council President Rounds thanked the mayor and again thanked her for allowing Director Sepik to provide us with an updated tour this evening at Nathan Hale. It was quite an amazing experience to see the work that has come together between NEORSD, County Councilman Scott Tuma, the city, the Federal work that went into that. It's quite amazing and beautiful. Thank you very much. Any other comments or questions for Mayor Gallo? Seeing none....

COMMUNICATIONS

Council President Rounds began with Councilman Haase's update of the Planning Commission meeting that was held on December 4th, 2023.

Councilman Haase stated that there are four ordinances on tonight's agenda, items 5 – 8 that the Planning Commission forwarded back to council's consideration. They are basically matching what other neighboring communities are doing that relate to not only the Clean Water Act of 1972, but also meeting certain EPA requirements.

Council President Rounds also read the liquor permit application from Mondo Beverage Drive Thru LLC, 7177 W. 130th Street, Parma Heights, OH, 44130. Chief of Police has recommended that this application be approved. If there's no objection from council, we'll forward this on without a request of hearing. Any objection? Seeing none. That application will stand as approved.

Councilman Haase added that just in case you haven't noticed. Motley 7 Brew location on Pearl Road opened on Monday. That obviously went through the Planning Commission. They were offering free beverages to folks. Stop by to get a coffee, iced tea or something else of your choosing.

Mayor Gallo added that we could do the appointments and reappointments during this time, I would appreciate it.
