### REPORTS FROM MAYOR AND DIRECTORS

Council President Rounds continued with the Reports from the Mayor and Directors, we'll begin with Recreation Director Bacci....

Recreation Director Bacci: Our completed projects were the Leprechaun Hunt. We had over 100 participants and was held at the Cassidy Theatre. I wanted to thank Councilwoman Durichko for stopping by. Spring crafts were just completed with over 70 people registered; we had people waiting at the door in case there was an opening. Summer baseball is still open for registration, tentatively we will be closing registration in late April. We will be offering OSHA training to all the coaches and their assistants through the Coaches Tool Chest. Spring soccer is now closed, we have 80 Munchkins (3 & 4 year olds) who will play at the Reservoir. The mayor's office and the Parma Heights City Library have partnered together for the Seed Library. Seeds are free. Earth Day is coming up on April 27<sup>th</sup> from 1 to 4:00 p.m. at Greenbriar Commons. We'd like to thank the Service Department for always helping us out whether it's with the baseball fields or just noticing an extra helping hand is needed. I'd also like to thank the Law Department for allowing us to have these ideas but also not shutting us down right off the bat when we come to them with these ideas.

Council President Rounds: Any questions or comments for Director Bacci? Councilwoman Maruschak...

Councilwoman Maruschak asked if the tennis nets are up at the tennis courts?

Director Bacci said we plan on getting them up next Monday. We are watching the weather very closely.

Council President Rounds: Any other questions or comments for Director Bacci? Seeing none. Thank you. Safety Director Scharschmidt.....

Safety Director Scharschmidt: Fire Department news; Lieutenant Sparling provided his Fire Prevention lecture at the Senior Center last week; he did an outstanding job as he settles into his position as Fire Prevention. He does fire inspections throughout the city and training for the Fire Department. Hydrant flushing will begin next Monday, April 1st. Police Department news; last week our 2018 double homicide case resulted in a conviction and death penalty was confirmed by the appellate court. While talking with the prosecutor about the case, she had very good things to say about the way the detective bureau handled the matter. Lastly on June 21<sup>st</sup> both the Police and Fire Departments will be

conducting RTF (Rescue Task Force) training including active shooter training and best practices for first responders. We'll be conducting this training with the Parma Police and Fire Departments. This training will be covered by the County funds including any overtime costs. It's certainly very important to keep our skills sharp and continue training.

Council President Rounds: Any questions or comments for Director Scharschmidt? Councilmember Maruschak....

Councilwoman Maruschak asked about the Citizens Police Academy this year?

Director Scharschmidt responded that we have suspended that program this year.

Councilmember Haase commented that this happens to be First Responder Wellness week from the 25 – 29<sup>th</sup> of March; congratulations and thank you to all our first responders for all they do for the city.

Council President Rounds asked about the softball game date?

Director Scharschmidt responded that a date has not yet been set.

Council President Rounds moved on to Service Director Sepik.....

Service Director Sepik: Thank you, Council President. The Kingsdale and North Church bids will be published on 3/27 and then again on 4/3. All bids will be sealed when received by me up to 11:30 am on 4/16/24. All bidders must be registered with Bid Express to be submitted. Only electronic bids will be accepted. Furthermore, Kingsdale and North Church has some curbs where we will deem them extremely bad, it's up to the residents to maintain their curbs and aprons. If you get any calls about why we're not doing the curbs, it's actually the resident's responsibility to maintain those areas. Back in 2022, 2022-13 legislation was passed for First Energy to replace our street lighting to LED lighting. You will see a lot of First Energy trucks out; we have about 95+ fixtures that will be updated to the LED lighting on the main streets. The recycling guide should be going out the first week of April. We partnership with the Solid Waste District on that publication. Thank you.

Council President Rounds. Any other questions or comments for Director Sepik? Councilmember Durichko....

Councilmember Durichko asked about the curb, I'm not sure I understand what you mean.

Service Director Sepik responded that the entire curb along the tree-lawn, belongs to the resident. If it's cracked, crumbed, broken it's the resident's responsibility to repair the curb.

Councilmember Durichko responded your talking about Kingsdale or in general?

Service Director Sepik added that we will be resurfacing Kingsdale and if we have to do it for a reason because there's a sewer grate or catch basin there, we will replace that certain area, but if it's broken and it's just part of the curb, we're not going to repair that.

Mayor Gallo added that Council may remember that when we resurfaced Pearl Road, some resident's aprons and sidewalks were part of the project. That's due to special circumstances as the director explained and at our discretion. It is the law of the city that these areas are the resident's responsibility to maintain.

Councilmember Haase asked when do you anticipate the actual work will begin?

Service Director Sepik responded that we're hoping once the bids come in, after review, perhaps around June 1<sup>st</sup>, maybe July 2024 depending on their schedule.

Councilmember DeSouza asked if Kingsdale and North Church will be closed for traffic or will it remain open with just one lane?

Service Director Sepik responded that we will keep them open as long as we can unless it becomes a safety issue, then we'll have to close it down. For the residents on the street, it will always remain open, local access would be closed.

Council President Rounds asked if there were any further questions or comments for Director Sepik? Seeing none. Finance Director Iaconis....

Finance Director Iaconis: Thank you, Council President. The 2022 audit was released, it is available online. We are starting 2023 very shortly. Our new Assistant Finance Director, Corey Rummell will be starting on Monday. We will get him to a meeting so that Council can meet him. The legislation involving the issuance of notes, I would ask for them to be two readings verses three. If you receive correspondence regarding DUO, it is to set up your two factor authentications, that is a legitimate e-mail. We are transitioning from the other authenticator. DUO multifactor will be city wide.

Council President Rounds asked if there were any further questions or comments for Director Iaconis? Seeing none. Good to see you Director Schneider, thank you for your help earlier this evening. Mayor Gallo.....

Mayor Gallo: The Senior Center served and delivered 1,308 meals over the past two weeks. They took a lot of trips and activities during the month of March. April they are looking at doing multi-generational events. They do a lot of coordination with the Donna Smallwood Center in Parma. There will be a senior prom at Normandy High School. They will be going to Sword and Sheild restaurant, the Invader Style salon so they can get ready for the prom. Mr. Sebes was here last caucus; they started the planting of the trees at Nathan Hale. We are closing out the funding for the theatre that we had from last year and this year, which included decking, paint and carpeting. We look forward to working on the next phase. We will let council know of the grand opening date of the Nathan Hale project. This basin also helps the City of Parma, so there are many elected officials from other cities that would like to be there. I'd like to go back to Councilwoman Maruschak's question about the Citizens Police Academy. There were 29 felonies in February, I previously have mentioned that we will be coming to you to transfer funds to give the department more overtime funding, therefore we will suspend the academy until next year as well as the purchase of a drone. We are paying close attention to the budget numbers. That concludes my report, Mr. President.

Council President Rounds thanked the mayor and stated that he understands the suspension of the Citizens Academy for this year, but I really hope that comes back, it's very well attended, appreciated. It would be great to see that come back. Any other comments or questions for Mayor Gallo? Seeing none.
