<input type="checkbox"/> Location: 10"-0" or more from residence, 10' 0" or more from any property line. Pool deck 3'-0" or more from property line.	
<input type="checkbox"/> Yard must be completely fenced at least 4'-0" high, pool area must be fenced or have fence directly attached to pool at least 3'-0" high. (Separate fence permit required)	
<input type="checkbox"/> Filter must be concrete pad or patio blocks. (Separate concrete permit required)	
<input type="checkbox"/> Pools must only be drained according to Ohio EPA standards.	
<input type="checkbox"/> Above hanging electrical wires must be a minimum of 22ft from top of pool/hot tub.

12. All appropriate fees and plans shall be submitted with application. Fees are not refundable. Any alteration to the original proposal will, at the discretion of the Director of Public Service, be considered a new proposal and will be charged accordingly.

Re-Inspection Fee: A fee of fifty dollars (\$50.00) shall be charged for each additional re-inspection.

Plan Changes: An additional fee of 50% of the original permit

Work Without Permit: The permit(s) cost shall be doubled for work begun or completed without obtaining a permit.

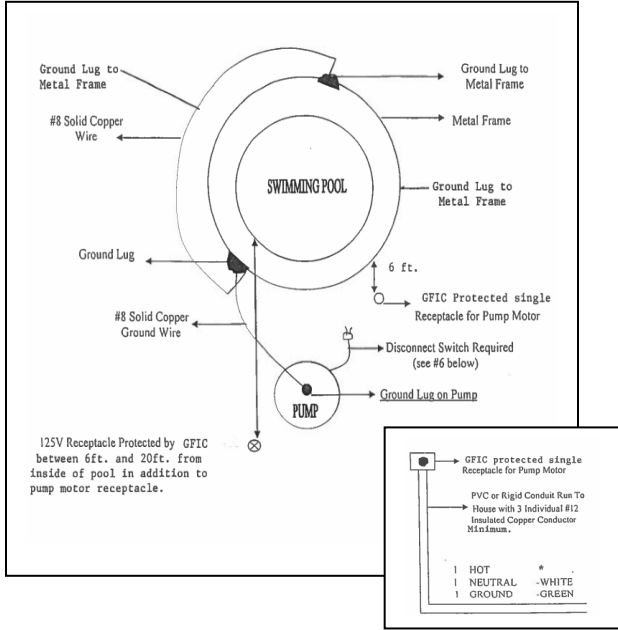

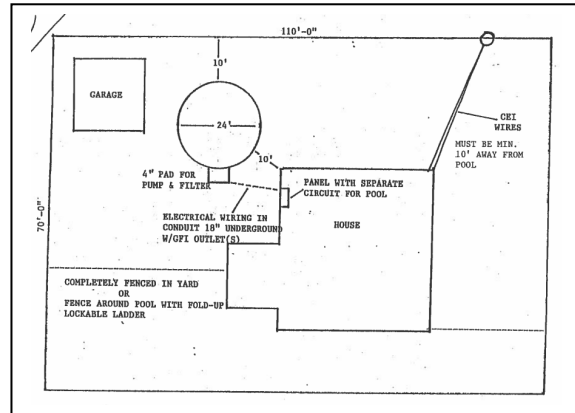
APPLICATION FOR RESIDENTIAL POOL AND HOT TUB PERMIT



Electrical Wiring Layout

1. Compliance with N.E. C., Art. 680
2. #8 solid must connect pump & metal frame of pool together- at 4 points plus pool skimmer.
3. Run conduit to dwelling, then inside dwelling cable assembly must also have insulated green ground wire, white neutral, and hot (any color except green or white)
4. Conduit buried 18 inches (keep open for inspection)
5. Before inspection: pool must be completed & 18" ditch kept open
6. Disconnect switch required at least 6 ft. from pool horizontally or located within sight if hard wired to pump
