RESOLUTION 2024 - 39

A RESOLUTION RECOMMENDING AND SUPPORTING MAYOR KIRSTEN HOLZHEIMER GAIL TO BE THE MAYORS AND MANAGERS APPOINTMENT TO CUYAHOGA COUNTY'S 9-1-1 COMMITTEE, AND DECLARING AN EMERGENCY

WHEREAS, the City of Parma Heights, Ohio is located within the County of Cuyahoga and is therefore part of Cuyahoga County's 9-1-1 service network; and

WHEREAS, Cuyahoga County convenes a 9-1-1 Program Review Committee in accordance with Ohio Revised Code, Section 128.06 (B); and

WHEREAS, Ohio Revised Code, Section 128.06 (B)(4) specifies that all municipal corporations within Cuyahoga County are entitled to one vote as to the Chief Executive Officer of one municipal corporation, who shall represent on the 9-1-1 Program Review Committee, all chief executive officers of all municipal corporations within Cuyahoga County; and

WHEREAS, said representative shall be selected by the majority of the legislative authorities of municipal corporations in Cuyahoga County; and

WHEREAS, the Mayor recommends that this legislative authority nominate and cast its vote for Mayor Kirsten Holzheimer Gail of the City of Euclid, Ohio to serve on Cuyahoga County's 9-1-1 Program Review Committee as the representative of all chief executive officers of all municipal corporations within Cuyahoga County.

NOW, THEREFORE, BE IT RESOLVED by the City of Parma Heights, County of Cuyahoga, and State of Ohio:

<u>Section 1.</u> This Council hereby nominates and votes Mayor Kirsten Holzheimer Gail of the City of Euclid, Ohio to serve on Cuyahoga County's 9-1-1 Program Review Committee as the representative of all chief executive officers of all municipal corporations within Cuyahoga County.

Section 2. This Council finds and determines that all formal action of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of the Council and of any of its Committees comprised of a majority of the members of the Council that resulted in those formal actions were in meetings open to the public, in compliance with the law.

Section 3. This Council declares the Resolution to be an emergency measure for the immediate preservation of the public health, peace, and safety of this Municipality, and for the further reason that it is necessary to have the 9-1-1 Program Review Committee Representative by May 17, 2024; wherefore, it shall be in full force and effect immediately after its passage by Council and approval of the Mayor.
