REPORTS FROM MAYOR AND DIRECTORS

Council President Rounds continued with Reports from Mayor and Directors

Recreation Director Bacci: Starting out with a thank you to the Garden Club who generously donated native plants from their plant sale to plant around Cassidy Theatre. It was very unexpected and we were happy that they reached out to us. The Memorial Day Parade was yesterday, we are very grateful to Mayor Gallo for bringing the parade back to Parma Heights. It was my first parade, it seemed to be a well-attended event with streets being lined with residents. Pitch-Hit and Run was held this past Saturday, we welcomed the Cleveland Guardians Charities. Three members of their Charity Board along with Mustard and Onion mascots were there to run around the field. The Parma Heights pool opened this past weekend for residents and members only. We have a couple weekends only before we will open up during the weekdays after school ends June 14th. We experienced a power outage on Saturday which made us close the pool early, systems are working fine. Youth Sports Night at the Guardians game is coming up on Tuesday July 23rd at 5:30 p.m. You can purchase tickets through the Recreation Department for \$23 per person, we currently have 120 people registered so we should fill an entire section.

Council President Rounds: Any questions or comments for Director Bacci? Councilwoman Durichko.......

Councilwoman Durichko commented about how amazing the Director performed on putting together the parade even with the challenges put before you. I want to thank the administration again for expanding the Yoga in the Park program with Jessica. This past Yoga in the Park event was well attended.

Council President Rounds: Any other questions for Director Bacci? Councilman Haase....

Councilman Haase asked about the Cassidy Theatre, this happens to be an Anniversary year, do we know when/if they are planning on having a Celebratory Event?

Director Bacci responded that she could reach out to Mr. Caraffi, I believe they did a gala off premises at the beginning of the year, but I will double check on that.

Mayor Gallo responded that the theater hasn't asked the city for any involvement, but if we get any information, we will certainly let council know.

Councilwoman Maruschak added that she had found a posting that stated September 20th at 6:00 at the Aviator.

Council President Rounds: Any other questions for Director Bacci? Seeing none. Safety Director Scharschmidt...

<u>Safety Director Scharschmidt:</u> Continuing with information regarding this year's parade, Director Bacci did an outstanding job. The Police Department had two key-note speakers that are currently officers in the Parma Heights Police Department. They were honored to be speakers this year. The mayor has received positive feedback from the community on the presentation from them.

Council President Rounds: Any questions for Director Scharschmidt? Seeing none. Service Director Sepik....

Service Director Sepik: Thank you, Council President. Garbage pickup will be delayed one day this week. Computer Round Up will be held June 8 from 9:00 a.m. to noon at the Service Garage. Our 2024 Street Rehab with Specialized Construction will be starting on Kingsdale. The resurfacing on Denison Boulevard, project, sealed bids will be open Monday, June 3rd at 11:30 a.m. I'd like to add a comment to the mayor, bringing back the parade was phenomenal. Kudos to you for bringing it back. I think the community lining the streets was a testament of their appreciation as well.

Council President Rounds. Any other questions for Director Sepik? Seeing none. Finance Director Iaconis...

<u>Finance Director Iaconis</u>: Thank you, Council President. I handed out general summary reports for the entire year. On the back is where you will see where we are with the balance from the beginning of the year. We are waiting for some revenue to come in. We have brought in \$12,593,000 so far this year and we've spent just over \$10 million. We will be pricing our debt on the 12th of June, so we will have an influx of money that has already been encumbered. The Mayor's Court, you will notice we brought in 87 citations. RITA completed the annual audit of their administration costs, based on our actual collections we will be getting a refund of \$207,000. Next month I would like to present our tax budget.

Council President Rounds asked if there were any further questions or comments for Director Iaconis? Councilwoman Palmisano asked if the funds in the Coronavirus account have to be spent on specific things, correct?

Director Iaconis stated that those funds have already been spent or allocated.

Council President Rounds asked if there were any further questions? Seeing none. Nice to see you, Director Schneider. Mayor Gallo......

Mayor Gallo: Thank you, Council President. Thank you for the kind words regarding the Memorial Day parade. It was huge undertaking by the administrative staff, we are very fortunate that our Police, Fire and Service Departments have historical knowledge of putting this parade together. I want to thank all of you for attending and assisting as well. Regarding the Senior Center, they served and/or delivered 1,323 meals in the last two weeks. I mentioned previously that they have received \$130,000 Healthy Aging Grant Fund from the Ohio Department of Aging and the money has to be spent by the end of September. The applications for the distribution for the Seniors Farmers Market is found online, which could be a bit challenging for some of our seniors. Our staff is going to assist as much as possible. Please let us know if you get any phone calls or concerns from members of the community. We have been distributing produce, meats,

dairy, canned and boxed foods the first Thursdays of every month from January of this year to May, we have served nearly 2,000 seniors, 65,000 lbs. of food. The program has been growing and nearly doubled in size. Seniors are going to a Lake Erie Crushers game tomorrow. Next week they are going to Lindy's Lighthouse in the Flats for lunch. The seniors were at the Memorial Day Ceremony, the parade and then went out to lunch afterwards. We have two more regular meetings before City Council goes out on Summer Recess. We will have to hold at least one special meeting for the Special Assessments that have to filed with the County by September 9th, and depending on how the library is moving along, we are still waiting for information from the library. They were hoping to break ground by summer, it is still moving along and we have a lot of things in place already. Thank you.

Council President Rounds: Any other comments or questions for Mayor Gallo? Seeing none.

Charlie Smialek, 6800 Commonwealth Blvd. I just want to thank the City of Parma Heights, specifically Safety Director Scharschmidt, Mayor and City Council. I am very grateful for the work that our Liaison Officer has done this year at Valley Forge. He is outstanding. I didn't personally have any role in selecting him. He is a true asset, everything you could possibly want in a Liaison Officer. Very grateful for the partnership and hopeful that we can continue because Valley Forge is a better place with him. Also thank you to the folks that operate the Senior Center, they have most recently opened their doors to our Valley Forge Choir, who sang there last Thursday. We have several sessions scheduled over the next couple of weeks with different groups to go there. We're always grateful for the opportunity to interact with the senior community and it's been another great partnership event. Thank you all.

Director Scharschmidt responded that we felt Matt Czech was a good fit. He's engaged and has done a great job there. Thank you, thank you for sharing your thoughts this evening.

Mark Podany, 6514 Alexandria Drive. My comment is about the so-called anonymous letter about the library. I've been in Parma Heights since I was two years old, I grew up using this library throughout High School and Junior High School and yes, I would love to be able to repurpose and save the building but sometimes you have to cut your losses. A friend of mine is a Master Mason who did repair work on the library's brick façade which was an add on after the library was originally built. He told me that the façade is shot, and they used the wrong type of bricks, the white glazing will be popping off from now forward. The a/c system is going to need to be replaced. It's going to be a waste of money. If you look at the restaurants in the area, Bob Evans, Arby's, Burger King's, when their buildings hit their end of life, they bulldoze them and start over again. Although my opinion might not be welcomed by all the residents, but you have to look at it in a reasonable manner of what it's going to cost the city. We can repurpose some buildings, but the library is not so much. Thank you for your time.
