### REPORTS FROM MAYOR AND DIRECTORS

Council President Rounds continued with Reports from Mayor and Directors, we will begin with Recreation Director Bacci....

<u>Recreation Director Bacci</u>: We wanted to express our congratulations to our baseball/softball/t-ball and swim teams. They all did very well over the summer. The pool is officially closed as of Saturday. We had about 300 people at the pool each day. Our Mayor threw out the first pitch at the Guardians game on July 23<sup>rd</sup>. We had

several folks from the senior center attend the game with us. We got to walk in the parade before the game as well. This past Saturday we had the Doggy Paddle, we had 26 furry friends and their owners come. Kaitlyn added onto the event by hosting a doggy swimsuit contest. Omega, Coco and Max were the winners of that event. Soccer started this past Saturday, September 7th. They are back at Nathan Hale; everyone seems excited about that. From 9 to 4:00 pm pretty much any Saturday you can catch a game. Yoga in the Park, we have two more Saturday's September 14th and September 28th at 10:00 am, we've been doing this since May, but closing out the season end of September in the Commons. Friday kicks off our Pickleball leagues. Josh has an adult league at 6:00 pm and a senior league at 10:00 am. Parma Heights Frights will be held Saturday, November 2nd. Mayor Gallo and the Young Professionals of Parma are partnering up which will be an elevated Creatures in the Commons and we're excited about this event.

Council President Rounds thanked Director Bacci and congratulated her and her staff on having a very busy summer. Ouestions or comments for Director Bacci?

Councilman Haase expressed a BRAVO

Councilwoman Palmisano asked if the information is available and if we've seen a drop in revenue from making a change to residents only.

Director Bacci stated that we just closed on Saturday so the totals haven't been reviewed as of yet. I'll know more after my last deposit is made. From May to September for the pool our memberships are 485 residents; and 241 for non-residents. About 1,000 resident day passes in addition to that and 1,500 non-resident day passes. I will be breaking that down further for our Recreation Commission.

Councilwoman Palmisano stated that she hopes the increase in residents who choose to use the pool now that it's not over crowded will help with that shortfall of non-residents. Me and my family very happily used the pool this summer because it wasn't going to be over crowded.

Director Bacci stated that we did see an increase in non-resident memberships because there are so many other activities that come along with it

Safety Director Scharschmidt: Good evening, Council. I'd like to begin with the Fire Department, they received a FEMA Grant for \$263,000 for S.C.B.A. – Self Contained Breathing Apparatus. Those are the tanks they wear on their backs during a fire. This equipment will meet with the current N.F.P.A. – National Fire Protection Agency's standards. The new squad arrives tomorrow, Chief Bernard is planning on having it here at the next City Council meeting so that you all have an opportunity to take a look at it. We have 33 candidates signed up with the National Testing Network, we are looking for 1 individual at this time to replace a retirement at the start of next year. On the police side, you all met Officer Badea when he was sworn in. He's graduated from Lorain County Community College last Friday. He and Jacob Pursley started their orientations today, you will meet Jacob soon. He is a lateral from Kent, Washington where he was an officer for three years and a military police officer for 5 years. His wife's parents are from Parma and recommended Parma Heights as his transfer location. There are 22 sign ups with the National Testing Network, we have a Sergeant that is retiring at the start of the year so we'll be replacing one and also promoting.

Council President Rounds asked if there were any questions or comments for Director Scharschmidt? Seeing none, Director Sepik......

Service Director Sepik: Thank you, Council. Our scrap tire round-up will be September 14th from 9 am to 12 pm at the garage. Denison Boulevard resurfacing is just about complete. They have to go back through and crack seal all the gutter and center line, crosswalks, ADA ramps. Our August 6<sup>th</sup> storm update is as follows; I'd like to publicly thank the mayor, our Public Works Coordinator Renee Overstreet, Flo Zimmerman, Stephanie Gebhard

and all of our Service Department and Fleet Maintenance workers: Bob Toler, Mike Cobb, Bob Collett, Eric Gebhard, Craig Bobeck, Tommy Gallagher, Mike Pelsnik, Tom Sarges, Ron Madej, Brian McDonnell, Dalton Reynolds, Tim Steimle, Adam Szabo, Sean Elliot, Chris Akins, and we had a part-timer Jimmy Bodrock who has now left to go back to school. Each one of them has done a phenomenal job, working overtime every single day for two weeks. We had 16 additional workers from ODOT assisting us with the clean-up for those two weeks. Clean-up still continues today, we have roughly 3,000 yards of tree mulch in the back of the Service Garage that will be hauled away. We have trees that haven't been mulched up yet also stored there as well. There was no push back from the staff in anyway, they knew what needed to be done and helped without question.

Council President Rounds stated that August 6<sup>th</sup> seems like it was such a long time past, but realizing this is our first Council meeting since then, I too would like to send a thank you to all the Service Department workers, as well as the Police and Fire Departments for the extra work that was thrust upon them because of that storm and the professionalism that they exhibited and the hard work that they did in making sure that our residents were kept safe. Mayor Gallo as well, I know you were out there as well. To the whole administration, thank you very much from all of us.

Councilwoman Maruschak wanted to mention that as I went around during the Community Yard Sale, I have to say how wonderful it was to see all the fire hydrants and addresses done. Thank you so much to the Service Department for helping us look uniformed during that time. I know that the residents appreciate it as well. I know this seemed like a long time ago too, but still warrants the acknowledgment. Those little touches just help our community look just that much nicer.

Director Sepik added that it helps police and fire really with the emergencies, but it all comes from the mayor. She asked that they get done, gave us the resources to do it, these are her touches that she adds to the city and I think it's great.

Council President Rounds called upon Finance Director Iaconis...

<u>Finance Director Iaconis</u>: Thank you. Working with the other directors to compile an estimate of storm related expenses to submit for potential funding from FEMA through the county EMA. We all worked together and put together our actual cost to date and then estimated how much more we were expecting to have to pay out. The bulk of those costs are going to be revolving around the Service Department and mostly wages due to the cleanup. We submitted just over \$1 Million dollars and that is putting in for about 6 weeks of labor. We are having some internal budget meetings finishing up the 2024 budget. We are also starting the 2025, which I should have something to present to you in either October or November. Just wrapping up our 2023 audit and we are making a lot of progress with the administrative code amendments and updates. Law Director Schneider has been a big help. I'm hoping that we will have something to present to council in October/November.

Council President Rounds asked if there were any questions for Director Iaconis? Seeing none. Director Schneider, nice to see you again. Thank you and your department as well for all the work that has gone on this summer around the dispensary, the library plus just the other normal things. There are 22 items on our agenda this evening, and I know that comes through your guidance and the work through Paralegal Tabar in your office.

Director Schneider stated that Megan Tabar, Barbara Allen, our entire Service Department who had a lot going on this summer, I'm happy to present these items to you that reflects the work that they did a head of time. You can't put forth 20 pieces of legislation without the whole Law Department working at full tilt. Specifically, the coordination with the referrals to the Planning Commission, publication requirements, preparations of packets, amendments, and all took place within such a compact summer, not to mention the Charter Review Commission, Barbara should be commended. My first job in public service was painting fire hydrants myself for two years in a row, when I was in high school. I'm very interested in the latest state of the art you speak of - a generator or power sprayer would have been considered cutting edge.

Council President Rounds responded thank you so much. Mayor Gallo......

Mayor Gallo: Thank you, Mr. President. Regarding our grants, the 2024 CDBG for Dennison Boulevard is complete and we are waiting on final payment for reimbursement; the 2024 CDSG for Cassidy Theatre renovations are nearing completion and the Natures Works application for Greenbrier Commons Playground has been submitted and award announcements are suspected to be provided the last week of November 2024. The 2024 Healthy Urban Canopy project has been awarded for the fall planting of the trees, there are 111 trees altogether after planted. Mr. Sebes has now completed the 2025 CDBG application which is on for this evening as well as the 2025 CDSG for the dog park. Regarding the Senior Center, they served and/or delivered 1,085 meals in the last two weeks. They are successful in using the entire \$130,000 Healthy Aging Grant from May 1st to September 30th. This was put towards transportation, meal preparation, home delivered meals and before August 1<sup>st</sup> we used all the congregate money but for \$519.00 in transportation and \$37,000 was spent towards those who are homebound. After the tornado there was no electricity, we were able to provide breakfast, lunch, dinner, ice cream, water, and coffee from August 7th - 9th to seniors. This was made possible through the help of the Healthy Aging Grant. We had a great summer, enjoying many activities including plays, baseball games, restaurants, concerts, trip to wineries, Amish trips, started the walking club, exercise clubs and presentations. They continue to sign up over 20 new seniors each month. We have 16 members registered to play Pickleball. Josh who works in the Recreation Department was kind enough to come to the Senior Center to sign them up. Move with the Mayor initiative started September 1 and runs through the 30th. I will be doing a walk this Saturday, September 14th at 9:00 am at Nathan Hale Park and next Wednesday, September 18th at the Connector Trails behind the Cassidy Theatre, all of Council is welcome to join us. That concludes my report for this evening.

Council President Rounds: Any other comments or questions for Mayor Gallo? Seeing none.

On the September 3<sup>rd</sup> meeting the lot consolidation for 5957 Hodgeman Drive was approved, and then the three pieces of legislation also on the agenda for this evening pertaining to the new Parma Heights Library that was discussed.
