#### REPORTS FROM MAYOR AND DIRECTORS

Council President Rounds continued with Reports from Mayor and Directors, we will begin with Mayor Gallo.....

On behalf of everyone in Parma Heights, we express our deepest gratitude and take great pride to call you ours. Congratulations on this remarkable achievement, and we look forward to many more years of theatre and success together.

Mr. Caraffi added that he wanted to take the opportunity to thank council, mayor and all of the directors, we would not be where we are without the partnership with Parma Heights. Back in 1974 the Cassidy Theatre was to be a hub of cultural excellence in the Greater Cleveland area and I think that we continue to strive for every day. From the bottom on our hearts, thank you for giving Cassidy Theatre, us and the artistic community of Greater Cleveland a place to call home. Thank you very much.

<u>Kimberly Mihalik</u> added that she is the Secretary for the Cassidy Theatre. I've grown up at Cassidy Theatre since I was 11 years old. It's been such a privilege to watch it go from Greenbrier to Cassidy and change hands. Theatres around here don't always last, so this is something really precious. This relation that the board has developed, we legitimately could not have been done without all of you. The fact that we know all of you and see you at our shows. We don't take for granted the relationship that we're building together. Thank you.

Councilman Haase stated that he was at the opening night audience in 1974. I think that Mayor Paul W. Cassidy and Elise are smiling down on you tonight and would be very proud of what has happened over the years. Congratulations.

Council President continued on with the rest of the agenda. You are welcome to stay, but feel free to excuse yourselves if you'd prefer. We'll begin with Recreation Director Bacci....

Recreation Director Bacci: At the beginning of this year, we applied for and have been awarded a grant for our equipment for softball and baseball teams for 2025. We are going to get between 30-40 new helmets and between 30-40 new face guards to protect the kiddos during play. Guidelines change over the years, so we were looking to make these upgrades in 2025 however this grant will significantly help, if not completely cover the costs in our budget. Our Mayor's Monarch Pledge of 2024 was submitted. Our Holiday Tree Lighting will be held Sunday, December 1st from 5:00 - 6:00 p.m. and then we will have stories with Santa on Saturday, December 14th, first sitting at 10:00 a.m. and the second sitting at 12:00 p.m. The Senior Center will be providing a Hot Cocoa Bar, we'll have stories and plenty of opportunities to take photographs with Santa.

Councilwoman Maruschak asked if there has been any word about the grant for the playground?

Director Bacci stated that she would check with Mr. Sebes and get back to you as soon as I have any information.

Council President Rounds asked if there were any questions or comments for Director Bacci? Safety Director Scharschmidt....

Safety Director Scharschmidt: Good evening, Council. We had an incident at Lydia's Strudel we are addressing. Police and Fire did a nice job, the Fire Department really went the extra mile. A vehicle went through the front window, fortunately no one was injured in that incident. Police continue to search for a new hire. Hopefully we will fill that void soon. Both departments will be at the tree lighting ceremony. Police Department will be participating in the "Shop with a Cop" helping numerous families. I'd like to wish all of you a Happy Thanksgiving

Mayor Gallo: Happy Thanksgiving to all of you and your families. The tree planting continues and should be completed by the end of the year. Still working on the Supplemental Grant for the theatre. No news on the Block Grants or SBSG grants but should be hearing something soon. The Senior Center has served and/or delivered 1,340 meals in the past two weeks. ARPA Grant funding \$6,500 went towards the Senior Center, replacing some exercise equipment including a portable mini golf course. Joe Sebes and Trish James went last Wednesday before County Council to give their presentation. Senior Center took two busses last week to the Cleveland Museum of Art and a dinner at PF Chang's. They had a great time especially at the Art Museum. This Wednesday they will be giving all 73 homebound participants and 71 congregate participants a meal plus two extra meals because the Senior Center will be closed Thursday and Friday. As Director Bacci stated the tree lighting is this Sunday, from 5:00 – 6:00 p.m. Looks like it's going to be cold. We have one more regular meeting before the end of the year. Right now, we don't foresee having to call any special meetings, but you never know though.
